Pt VI, Line 11b: The Form 990 is prepared by an independent CPA firm and reviewed
in detail by management and presented to the Finance Committee before filing.

The Finance Committee, led by the Board Treasurer, is responsible for financial
oversight of the organization. The board also receives a copy of the Form 990
before filing with the IRS.

Pt VI, Line 12c: The conflict of interest policy is provided to each board member
at the annual meeting. Members and officers must sign a statement acknowledging
they've received, read, understand, and agree to comply with the policy. The
President/CEO reviews these statements and the Executive Committee reviews the
President/CEO's statement. If new conflicts arise, members must promptly disclose.

If a true conflict exists (majority vote by board), that member would be precluded
from discussion and voting on the matter. Violations of the policy result in
appropriate disciplinary or corrective action from the governing board.

Pt VI, Line 15a: Compensation for the President/CEO is decided by the board
of directors. The board is independent, uses comparable market data in the determination
process, and records its deliberation and decision in the board minutes.
